Subject: Government Order of Md. Kamruzzaman, Scientific Officer, FMPHT Division BRRI to participate in the PhD program to be held at Northeast Agricultural University (NEAU), China during 01-09-2018 to 31-05-2022 or 3 years 9 months from date of release.

With reference to the letter from Ministry of Agriculture (Memo No: 12.00.0000.063.19.016.17.361, date: 28 August 2018 Md. Kamruzzaman, Scientific Officer, FMPHT Division BRRI is allowed to participate in the PhD program to be held at Northeast Agricultural University (NEAU), China during 01-09-2018 to 31-05-2022 or 3 years 9 months from date of release under the following terms and conditions:

- 1. The period of stay of the incumbent will be treated as on deputation for whom he will be entitled his usual pay, allowances etc. in Bangladesh. An actual transit will be allowed in both the ways.
- 2. The incumbent will not be given his pay, allowances etc. in foreign currency during his stay abroad.
- 3. All expenses in this connection will be borne by Northeast Agricultural University (NEAU).
- 4. A release order is to be obtained from the institute before departure.
- 5. He will inform his name, address, duration of stay etc. to the Embassy of the Peoples of Bangladesh to China with a copy to DG, BRRI.
- 6. He has to submit progress report for every six months to DG, BRRI. Failure to do this, his salary during deputation period will be suspended immediately.
- 7. He cannot overstay abroad beyond the approved period as mentioned above without the permission of the authority.
- 8. After return from abroad he will serve BRRI for a minimum period of 6 (six) years and will have to execute bond in this regard.
- 9. He will submit a report within 7 days of his return about what he has learned during PhD program.
- 10. He will present a seminar on the subject learned.
- 11. He will undertake research program based on the knowledge gained from the PhD relevant to the needs of BRRI research.
- 12. He will join the institute after return from abroad.
