Subject: Government Order of Dr. Sharmistha Ghosal, Senior Scientific Officer, Plant Breeding Division, BRRI to participate in the Post Doctoral Fellowship program to be held at Global Institute for Food Security (GIFS), University of Saskatchewan, Canada during 01-03-2023 to 27-01-2024 or 10 months 27 days from date of release.

With reference to the letter from Ministry of Agriculture, Memo No: 12.00.0000.063.19.006.17.103, date: 27 March 2023, Dr. Sharmistha Ghosal, Senior Scientific Officer, Plant Breeding Division, BRRI is allowed to participate in the Post Doctoral Fellowship program to be held at Global Institute for Food Security (GIFS), University of Saskatchewan, Canada during 01-03-2023 to 27-01-2024 or 10 months 27 days from date of release under the following terms and conditions:

- 1. The period of stay of the incumbent will be treated as on deputation for which she will be entitled her usual pay, allowances etc. in Bangladesh. An actual transit will be allowed in both the ways.
- 2. The incumbent will not be given her pay, allowances etc. in foreign currency during his stay abroad.
- 3. All expenses in this connection will be borne by Bangabandhu Research Chair, Global Institute for Food Security (GIFS), University of Saskatchewan, Canada.
- 4. A release order is to be obtained from the institute before departure.
- 5. She will inform her name, address, duration of stay etc. to the Bangladesh Embassy/High Commission in Canada with a copy to DG, BRRI.
- 6. She has to submit progress report for every six months to DG, BRRI and Ministry of Agriculture through proper channel. Failure to do this,

her salary during deputation period will be suspended immediately.

- 7. She cannot overstay abroad beyond the approved period as mentioned above.
- 8. After return from abroad she will serve BRRI for a minimum period of three years (03 years) and the remaining period mentioned in previous bond for her PhD.
- 9. She will submit a report within 7 days of her return about what she has learned during Post Doctoral Fellowship program.
- 10. She will present a seminar on the subject learned.
- 11. She will undertake research program based on the knowledge gained from the Post Doctoral fellowship relevant to the needs of BRRI research.
- 12. She will join the institute after return from abroad.
